Security Brands, Inc. access control products are manufactured in the United States. Consequently, we ensure that materials used in the manufacture of Security Brands, Inc. products will comply with the Buy American provisions of the Buy American Act (BAA). Security Brands, Inc. manufactures 95% of its products in its Mesquite, Texas facility. These products are produced domestically but are comprised of some imported materials/components, which must be substantially transformed to produce finished products.

The following Security Brands, Inc. product families meet these requirements:

- Ascent Family of Connected Access Control
- Advantage Family of Stand-alone Access Control
- RemotePro Family of Wiegand-output Keypads and Card Readers

These product families meet the requirements to be labeled "Made in the USA from Global Materials" and "Buy American Act Compliant."

The Federal Trade Commission (FTC) provides guidance on conformance with its "Made in USA" policy and the proper application and use of the phrase, "Made in USA," or a qualified phrase such as "Made in the USA from Global Materials."



Buy American Act Compliant

In addition to meeting the FTC's "Made in USA" policy requirements, the above product families are Buy American Act compliant. They meet the Federal Acquisition Regulation (FAR) definition of a Commercially available Off-The-Shelf (COTS) item, i.e., "a commercial item (item that can be sold, leased, or licensed to the general public); sold in substantial quantities in the commercial marketplace; and offered to the Government, under a contract or subcontract at any tier, without modification, in the same form in which it is sold in the commercial marketplace."
